6.1	Pupil Numbers - LC reported that pupil numbers are static at 94. Two open days were held as to trial a new format, they went well but for the investment in time it is not a model we are likely to adopt. There are still no clear indications of numbers for the intake in September, the Published Admissions Number (PAN) is 12, which together with intake for other classes are likely to reach 12 overall. 6.2	Attendance Data- LC was pleased to say that attendance for the first half term was 98.4 which is higher than last year. and better than the Devon average. Unfortunately the holidays in term time have not decreased despite efforts to combat this with formal procedures by DCC. Q. LCW asked if this was to do with families working in the tourist industry. LC responded to confirm that families genuinely affected by working in the tourist industry are very few. The school are keeping the pressure up, with face to face discussions with parents where possible, and referring offenders to DCC for formal process.	Complete

6.3	Staffing – LC reported that there has been increased pressure on staff, partly attributable to Gill attending the SENDCO training, and LC having to teach in Class 2. Overall the staff body are all fairly stable and performing well.	Complete	
7	School Performance Data – LC walked the meeting through the performance data using the screen projector. Using KS2 as an example LC explained in depth the statistical picture for the group. KS2 is above the local average and consistently above the national average, bearing in mind that Devon is poorly funded in comparison to most. Over the 3 year trend KS2 shows consistently good results, but due to the small size of the cohorts, just one child not achieving in one area of reading, writing and maths it can dramatically affect the statistics resulting in an amber light on the system. Within a cohort we have had a child with significant health issues throughout the year, which in regular sized cohort over 3 years would be easily absorbed statistically, whereas in our very much reduced sizes has a very apparent effect statistically. Governors need to be mindful of the small cohort size when looking at the traffic light indicators for our data, and dig a little deeper. Despite this LC reassured the meeting that the school always exceeds national average. Q. LCW asked how the school compared to K&K for example. LC explained that each school is different and so a direct comparison is not always helpful, but compared to the local average we usually exceed this.		
8	Monitor Pupil Progress against the SIP – LC informed the meeting that the data had not yet come through for this term, in looking at the SIP Governor Questions Framework. LC responded to a questions from Governors posed in the framework. There are some issues around lateness for 8-10 families which persists despite parents being challenged. There are absences due to medical appointments, which impacts of learning.
