Here is the October newsletter for you.

We are looking to remove the class bubbles after half term; we needed to put these in place as we are such a small site and I think that with the Covid cases that we have experienced within the school, this was definitely the correct things to do for everyone. I think this will be how the school must run for the coming months, but our goal now is to ensure we can provide as many of the enrichment opportunities that we so enjoy.

We also welcomed Kip Pratt, who taught the children some lovely playground songs. We have received some wonderful Music enrichment from experts during the last two weeks.



#### Can you help shape the future of our school?

We need parents of pupils registered at the school or members of the local community to make a difference in our school's community by volunteering to become **governors**.

Currently we have vacancies for parent governors and co-opted governors on the governing body.

Your voice is very important to our school and it is vital that the governing body has good representation of our parents and our local community among its membership.

#### Information about the role

Once elected or appointed for a term of four years, you will take on the role of a school governor, a public volunteer. All governors are equal, no category of governor is any more important or influential than any other. Parent governors exercise a strategic parental voice on the governing body and community governors identify how the school impacts on the local environment.

We are seeking people who have a real willingness to help, who can listen carefully, read important documents, ask questions, attend training and be able to actively contribute at meetings.

If you can spare approximately eight hours or more a month then please consider nominating yourself for this interesting voluntary role.

The governing body is particularly seeking applicants with skills relating to finance monitoring, health & safety and premises management.

# What can you offer as a governor?

- Enthusiasm, time and commitment.
- Your local knowledge will be valuable: you will have a feel for what is important to people.
- Any professional or other skills you may have will be very helpful.
- An openness to learning and change, and wanting to make a difference.
- Governors also provide objectivity in debate and decision-making and can add further and different perspectives to school matters.

#### What are the benefits?

- Being a school governor is a privilege you are a small but very important part in an educational system with a very long history.
- The knowledge that you have played a part in improving local children's education and supported the school's staff.

- A chance to develop new skills, to practice and strengthen existing ones, such as chairing a meeting, researching or leading on a key school issue.
- The opportunity to work as part of a team to make a real difference in the community.
- The opportunity to meet new people from all walks of life whom you probably would not have otherwise encountered.
- Knowing that the decisions you collectively make will have a huge impact on children's lives.
- You develop as a person and may even find that your experiences as a governor influence future career and life choices.

# If you are interested in volunteering, here's what you should do ...

- 1) Please check that you are eligible to stand as a parent governor or a community governor. The definition of "parent" includes:
  - all natural parents, whether they are married or not: and
  - any person who, although not a natural parent, has parental responsibility for a child or young person;
     and
  - "Parent" is defined as including "any individual who has or has had parental responsibility for, or cares or has cared for, a child or young person under the age of 18". It includes a person who the child lives with and who looks after the child, irrespective of what their relationship is with the child. The reference in the definition must be to someone involved in the full-time care of the child on a settled basis.

There are some criteria which can disqualify you from serving as any type of governor. This list is copied at the end of this letter. If you are applying, then you must confirm that you are not disqualified by those criteria.

2) Please send an initial email of interest to <a href="mailto:clerk@cockwoodschool.co.uk">clerk@cockwoodschool.co.uk</a> stating whether you are seeking to become a parent or community governor. One of our current governors will be in touch to arrange an informal chat and pass on an application form.

# For parent governors only.

If the school receives more applications than there are vacancies, then we will hold an election and parents will be asked to take part in a secret ballot to vote for the candidate(s) they feel would be most suitable as a parent governor. The information you supply as part of your nomination will be circulated to parents to help them decide who to vote for. Your personal contact details will not be distributed.

If the school receives the same number of applications as there are vacancies, then those nominees are deemed to be 'elected unopposed' and become parent governors without the need for an election.

If no parents apply, then the governing body become responsible for appointing parent governors to fill the vacancies. If they can't find volunteers at our school then they may seek parent volunteers from other schools.

If an election needs to take place then I will inform all nominees personally, and all parents in writing, providing the details of how to vote and the deadline for doing so.

If there are any questions or you need further information, please let me know as soon as possible.

# Eligibility

#### I confirm that:

- I am aged 18 or over.
- I am not a pupil at Osprey Learning Trust
- I am not an undischarged bankrupt.
- I am not disqualified from acting as a charity trustee under Section 72 of the Charities Act 1993 Section 72 of the Charities Act 1993 provide a person will be disqualified as a charity trustee for:-
  - conviction of any offence involving dishonesty or deception (unless the conviction is spent);
  - being adjudged bankrupt or having his/her property made available to creditors and (in either case) he/she has not been discharged;
  - making a formal arrangement with his/her creditors which has not been discharged;
  - removal from the office of charity trustee by an order of the Charity Commissioners or of the High Court;
  - removal under Section 7 of the Law Reform (Miscellaneous Provisions) (Scotland) Act 1990 from being concerned in the management or control of any body; or
  - being subject to a disqualification order or disqualification undertaking under the Company
    Directors Disqualification Act 1986 or to an order made under Section 429 (2) (b) of the
    Insolvency Act 1986.
- I am not included in the list kept by the Secretary of State under Section 1 of the Protection of Children Act 1999.
- I am not disqualified from working with children in accordance with Section 35 Criminal Justice and Court Services Act 2000.
- I am not barred from regulated activity relation to children (within the meaning of Section 3(2) of the Safeguarding of Vulnerable Groups Act 2006.
- I am not the subject of a direction under Section 142 Education Act 2002 nor am I subject to any prohibition or restriction which takes effect as if contained in such a direction.
- I have not been convicted of any criminal offence, excluding any offence that is spent under the Rehabilitation of Offenders Act 1974 and any offence for which the maximum sentence is a fine or a lesser sentence.
- I am not under a disqualification order made by a Court under the Company Directors Disqualification Act 1986.

A disqualification order <u>must</u> be made against a director if he/she is or has been a director of a company which has at any time become insolvent and his/her conduct as a director of that company (taken alone or together with his/her conduct as a director of any other company or companies) makes him/her unfit to be concerned in the management of a company.

A disqualification order <u>may</u> be made against a director for:-

- conviction of an offence in connection with the promotion, formation, management, liquidation or striking off of a company or with the receivership or management of a company's property;
- persistent breaches of company's legislation (e.g. failure to file accounts and annual returns);
- fraudulent trading or of any other fraud in relation to the company;
- conviction for contravention of or failure to comply with any provision in companies' legislation requiring the filing of documents with the registrar of companies; or
- participation in wrongful trading.

From 1 August 2018 individuals are automatically disqualified from acting as a governor of a school if:

- one or more of the reasons in Annex A apply; and
- they have not obtained a waiver of that disqualification from the Charity Commission.

#### I declare that:

- I am not disqualified from acting as a governor and
- I will inform the Cockwood governing body promptly if, after the date of this declaration, one or more of the disqualification reasons applies to me.
